* Foundation Governors are appointed by the Trustees, the Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.

** All Governors' terms of office are 4 years.

The Governing Body appointed Finance, Premises & Personnel Committee, Curriculum & Pupil Matters Committee and Pay & HTPM Committees in September 2022 – other appeals committees will be appointed as and when required.

The Full Governing Body ratifies decisions following recommendation from the committees/panel above (unless otherwise stated in School Policy/Terms of Reference/Scheme of Delegation), and all minutes are available, upon request, from the school with the exception of confidential minutes.
